

HMRC announce changes to advisory fuel rates from 1 March 2016



DRIVING PROFITABILITY SINCE 1975

These rates apply to all journeys in a company car on or after 1 March 2016 until further notice.

For 1 month from the date of change, employers may use either the previous or new current rates, as they choose. Employers may therefore make or require supplementary payments if they so wish, but are under no obligation to do either.

Engine size	Petrol	LPG
1400cc or less	10p	7p
1401cc to 2000cc	12p	8p
Over 2000cc	19p	13p
Engine size	Diesel	
1600cc or less	8p	
1601cc to 2000cc	10p	
Over 2000cc	11p	

Hybrid cars are treated as either petrol or diesel cars for this purpose.
